

CONTRACT FOR LABOR AND/OR SERVICES

AGREEMENT made this _____ day of _____, 20____ between DAWSON COUNTY FAIR, of 207 W. Bell St., Glendive, MT 59330 hereinafter referred to as DAWSON COUNTY FAIR and

_____ of _____ hereinafter referred to as the INDEPENDENT CONTRACTOR.

The parties of this Agreement, in consideration of the mutual covenants and stipulations set out herein as well as the good and valuable consideration to be paid by DAWSON COUNTY FAIR to the INDEPENDENT CONTRACTOR, agree as follows:

1. **Duties** The INDEPENDENT CONTRACTOR agrees to perform the following work or provide the following services for DAWSON COUNTY FAIR:

2. **Term** The INDEPENDENT CONTRACTOR agrees to work for DAWSON COUNTY FAIR or provide services as set forth above during the _____ Dawson County Fair.

3. **Payment** DAWSON COUNTY FAIR shall pay the INDEPENDENT CONTRACTOR the sum of \$ _____ per hr./ or \$ _____ for the work to be performed or the services provided.

4. **Taxes** The INDEPENDENT CONTRACTOR will be responsible for his/her own State and Federal taxes and no deductions for State or Federal taxes shall be made from the amount due to the INDEPENDENT CONTRACTOR by the DAWSON COUNTY FAIR.

5. **Employment** The INDEPENDENT CONTRACTOR will not be considered a permanent employee of DAWSON COUNTY FAIR and is being hired only for part-time contract labor and/or services.

6. **Insurance** The INDEPENDENT CONTRACTOR shall be responsible for his/her own medical and hospitalization insurance and all other forms of insurance, other than that required to be paid by DAWSON COUNTY FAIR in the form of Worker's Compensation Insurance, by State law.

7. **Termination** This Contract for Labor and/or Services may be terminated by either DAWSON COUNTY FAIR or the INDEPENDENT CONTRACTOR at any time by a verbal or written notice of 3 days.

8. **Applicability** This instrument contains the entire agreement between the parties and no other statement, promises of inducements made by either party or agent of either party that is not contained in this written Contract shall be valid or binding and this Contract may not be enlarged, modified or altered except in writing signed by the parties endorsed hereon.
