We are **encouraging** vendors to be operational Thursday by 6:00 P.M. because of the observed increase in traffic Thursday evenings. The carnival opens Thursday evening. There is free-stage entertainment and a Grandstand event Thursday evening as well. We hope you will find this extra time at our fair will be beneficial to your business. Indoor Vendors: If you cannot make it Thursday, we will display a “coming Friday” sign with your vendor info inside your reserved booth.

### GATE ADMISSION:

\$2 per person over 5 yrs old on Thursday 5 – 9 P.M., Friday noon – 9 P.M., and Saturday 9 A.M.- 9 P.M.

We will supply you two vendor passes. You can purchase more for your workers at the fair office.

### SET-UP:

Thursday: noon to 6:00 P.M.

Friday: 7:00 A.M. to 11:00 A.M.

Outdoor vendors at the center gate and north street areas: Please coordinate set-up with the fair office so as not to interrupt livestock judging

### PARKING:

Booth vendors may park in the designated first row of the parking lot. Gate attendants will allow you to come to your booth area for delivery if you show them your vendor pass, but you must return to the parking lot when your delivery is complete.

### DELIVERIES:

Deliveries to your booth must occur prior to 6:00 P.M. Thursday; prior to 11:00 A.M. Friday/Saturday; and prior to noon Sunday.

No unauthorized vehicles will be allowed after these times.

### GRANDSTANDS VENDOR AREA:

Access to vendors: 10:30 A.M. Friday, Saturday, Sunday

Open to public: 6:00 P.M. – 10:30 P.M. Thursday

11:00 A.M. – 10:30 P.M. Friday

11:00 A.M. – 10:30 P.M. Saturday

Noon – 4:00 P.M. Sunday

Booths will be supplied with one table and two chairs. Please, no large nails to hang anything on walls

(over please)

**TEAR-DOWN:**

Sunday at 4:00 P.M. unless prior arrangement is made with fair board or manager.
